Terms of Reference for Impact assessment of Field Test Kit (FTK) used in water quality monitoring and surveillance program

1. Background

Water quality monitoring and surveillance is a critical component of Jal Jeevan Mission. It is helpful in verifying the safety of drinking water supplied through the GP level water supply systems. Water quality surveillance is expected to be done by the GPs/ rural community to know the extent of contamination. Five women from each village are to be identified and trained to undertake surveillance activities with help of Field testing Kits (FTKs). All drinking water sources/ supply points in the village including private sources are to be tested using FTKs and the test results are to be submitted to the RWS Department for necessary action.

SWSM, Maharashtra has been taking efforts for ensuring effective water quality surveillance in GPs. As a part of these efforts, FTKs have been procured and distributed to GPs, GP level Jalsurakshak and selected women from villages have been trained for FTK testing in FY 2023-24. The WQ testing data is submitted by GP on WQMIS portal. So far, 40327 chemical FTK and 20,50,750 bacteriological FTKs have been distributed to GPs across the state and 2,04,161 women from 40,184 villages have been trained on water quality surveillance^[1].

SWSM now intends to undertake impact assessment of the initiative and proposes to engage a technical support agency for the assessment. This is the ToR for the same.

2. Purpose and objectives

The main purpose of the assessment is to study the level of awareness about FTK among GP stakeholders, availability of FTKs, utilization of FTK for water quality surveillance, impact of FTK use on water quality, community feedback on the results of FTK use and involvement of ASHA, ANM and MPWs in the surveillance process; and to recommend the way forward. The specific objectives are as follows-

- To understand the details of training given to the women and Jalsurakshak and their existing status
- To understand the process followed at the district level for distribution of FTKs
- To understand the use of FTKs at village level by the women and Jalsurakshak and its availability, utilisation, corrective measures and submission to laboratory, community feedback on the results of FTK use on water quality and household level water management practices and involvement of ASHA, ANM and MPWs in the surveillance process

- To validate the reporting on IMIS for FTKs under JJM
- To identify good practices regarding FTK use prevailing in the state
- To recommend the way forward for efficient use of FTKs

3. Status of WQ surveillance in Maharashtra

SWSM undertook trainings of 5 women for WQ surveillance from each GP in FY 2023-24. Under the initiative, 2,04,161 women from 40,184 villages have been trained so far. Following table presents the district wise distribution of women trained for testing water samples using Field Testing Kit (FTK).

4. Proposed methodology

Following steps are expected to be undertaken for the impact assessment-

- 1. Desk review of data, documents and information regarding distribution of FTKs, details of trainings on FTK use, FTK testing data, etc. to understand the status of water quality surveillance in GPs. An inception report detailing the methodology and report of desk review will be submitted by the agency.
- 2. Development of assessment tools (Interview questionnaires, FGD pointers, interaction checklists, etc.) and their approval
- 3. Field assessment of WQ surveillance in 72 sample villages from 6 districts. For the study, one districts will be selected from each division (total 6 districts). The assessment will be done in four small GPs, 4 medium GPs and 4 big GPs from each district. This means 12 GPs will be selected from each district for the assessment totalling to 72 GPs. The districts selected for the assessment will represent various administrative and agro-climatic zones, status of achievement in terms of number of trainees, FTKs procured, samples tested, population, distance from block or district, rural tribal, coastal, quality affected, etc.

The assessment will include the following steps-

- Interactions with state officials
- Interactions with DWSM officials from 6 districts
- Interaction with BDOs from 6 blocks
- FGD with GP/ VWSC members and 5 women selected for WQ from each GP
- Semi structured interviews of 1 woman selected for WQ and Jalsurakshak from each GP
- Discussions with community members on the results of FTK use on water quality and household level water management practices

- Visit to drinking water sources, demonstration of testing using FTKs, review of records, etc.
- 4. Data entry and analysis
- 5. Key findings and preparation of impact assessment report
- 6. Identification of good practices and development of a coffee table book

5. Deliverables

The deliverables will include assessment tools and the impact assessment report.

6. Estimated duration

The estimated duration of the contract will be of 3 months.
